# **PUBLIC INPUT**

#### **COMMENTS & ANNOUNCEMENTS – MAYOR**

Mayor Jones informed those that may not have heard of the loss of Chief Joellenbeck's daughter Katie this morning in a motorcycle accident. His family is in our prayers.

# **COMMENTS & ANNOUNCEMENTS- ALDERMEN**

Alderman Weh wants the City to see what we can do to upgrade the restrooms at the grandstand. He has received complaints on both the ladies and mens.

# COMMENTS & ANNOUNCEMENTS – CITY STAFF

Clerk Buzzard informed the council that the annual audit site work has been completed. There are still some things that she needs to complete and forward to the auditors but overall everything went well.

Mr. Brimm met with Phil Moss regarding the return of Navy Electrician's Mate 3<sup>rd</sup> Class William Klasing to Trenton this Friday. The procession is expected to arrive at the New Baden exit off Interstate 64 around 4 p.m. and travel east on Route 161 to the intersection at Route 160. It will then turn north to Trenton where it will turn east on Old Route 50. It will proceed through Trenton to Breese where the remains will be kept overnight. On Saturday morning the remains will be brought to Moss Funeral Home in Trenton. The procession will depart at 10:45 a.m. from Moss Funeral Home and travel down Broadway to Ash Street where they will enter the cemetery for an 11:00 a.m. burial. Parking will be near diamond 6 with overflow parking in Jim's Formal Wear's lot and if necessary on the grass at the four small diamonds. There will be street closures on both Friday and Saturday so please be patient. Updates will be posted on the City's Facebook page.

# **CONSENT AGENDA**

Alderman Deien made a motion to Approve the Consent Agenda as read. Second Alderman Weh, all yes. Motion carried. The consent agenda included the minutes of the June 10, 2019 Regular Council Meeting, approval of the corrected February 2019 Treasurer's report, approval of the corrected March 2019 Treasurer's Report and approval of the April 2019 Treasurer's Report.

# **UNFINISHED BUSINESS**

The appropriations ordinance must be passed by the end of July so Mr. Brimm would like to call a Finance committee meeting to review the budget numbers. Mr. Brimm gave the highlights of the budget so far. Mayor Jones will set the committees at the next meeting and call a Finance

Committee meeting for some time between July 8 and July 22. Mayor Jones said that we will not be as aggressive with projects this fiscal year to allow flexibility with the downtown renovation project and allow the public works department to catch up on some projects.

Alderman Mohme made a motion to Authorize the Upgrade of CodeRED at an Annual Cost of \$2,220.00. Second Alderman Deien, all yes. Motion carried. Mike Conley suggested using the Every Door Direct program from the post office to get information out to the residents.

#### **NEW BUSINESS**

Mr. Brimm informed the Council that the police are live with the e-citation program in Clinton County. Our license includes 2 in car printers. Chief Joellenbeck would like to purchase 3 more so that they don't have to be moved from car to car. Cost estimates for the additional printers are \$1328.58 from CDW and \$1501.65 from Amazon. These would be paid from the e-citation fees collected in the police equipment fund.

# **CLOSED SESSION**

Alderman Woods made a motion to enter into closed session citing 5 ILCS 120/2(c)(1) Appointment, Employment, Compensation, Discipline, Performance, or Dismissal of Specific Employees of the Public Body. Second Alderman Weh, all yes. Motion Carried. The Council entered closed session at 7:26 p.m.
