# TRENTON CITY COUNCIL REGULAR MEETING NOVEMBER 9, 2020

#### **CALL MEETING TO ORDER**

The Regular Meeting of the City Council was called to order by Mayor Kyle Jones at 7:00 p.m. on Monday, November 9, 2020 followed by the Pledge of Allegiance.

# PROCLAMATIONS/RECOGNITIONS/PRESENTATIONS

#### **PUBLIC INPUT**

Mr. Ian Henderson updated the Council on his fundraising efforts for his Eagle Scout Project of replacing the batting cage at the main diamond at the park. He would like the City to split the approximate \$12,000.00 shortfall in funding with the park boosters. This dollar amount would be in addition to the \$3,000.00 in concrete work that the City has already committed to. He was asked for clarification about the monetary shortfall if he planned only a single batting cage vs the double he is proposing. That shortfall is only \$2,500.00. The Council would like for him to get firm commitments from the rest of his non-committed organizations and come back with final numbers.

# <u>COMMENTS & ANNOUNCEMENTS – MAYOR</u>

Mayor Jones stated that Wednesday is Veterans Day. He is thankful and appreciative for those Veterans among us.

Mayor Jones reviewed the Fund Balance Report. The General Fund is showing a surplus of \$198,000.00 with the Water Fund showing a YTD deficit, but making strides. The Sewer Fund is also showing a YTD deficit, the North Business District is growing quickly, and the Capital Improvement Fund has over \$750,000.00. To date we have weather this pandemic storm well.

Alderman Woods stated that a Republic Services truck broke down in his neighborhood and left a large oil stain on the road. Administrator Marquart will reach out to the company to get this cleaned up.

# <u>COMMENTS & ANNOUNCEMENTS – CITY STAFF</u>

City Administrator Marquart informed the Council that the ITEP Grant was submitted in Springfield last week. He does not anticipate that we will hear anything back until the end of the first quarter 2021.
