### CALL MEETING TO ORDER

#### **COMMENTS & ANNOUNCEMENTS- ALDERMEN**

Alderman Brown asked for an update on the TIF extension that the City will be asking for. Mayor Weh said that he and clerk Buzzard had a teleconference last week with Jake Zambaldi from Moran Economic Development to discuss our next steps. Clerk Buzzard has prepared all the literature that will be sent to the taxing bodies. The next step is to reach out to each taxing body and discuss by phone prior to sending the information asking for support. Mayor Weh will reach out to Tina Litteken with Wesclin to schedule a meeting.

#### COMMENTS & ANNOUNCEMENTS – CITY STAFF

Director of Public Works, Brockhahn informed Council that the curbing at S King Oak and Indiana is completed and came in \$1,250.00 cheaper than the bid price.

There was more discussion about the crosswalks. Director Brockhahn has talked with IDOT and they will not approve any type of lighted crosswalk. IDOT uses a strip that gets burnt onto the road. Director Brockhahn would like to try that at the intersection of Broadway and Main. We already own all the equipment for the application. It is estimated the cost per crosswalk will be \$1,000.00.

OSLAD Grant update: the engineers have asked Director Brockhahn to provide all calculations for amps for all electrical appliances in the new concession stand. That project should go out on bid soon and be completed prior to next spring's ball season.

New playground mulch was put at both small playgrounds. Now a facebook message has requested new mulch at the large playground. That will be done this week.

Chief Joellenbeck said that the roof is on the shed at the range. Thanks to Terry Calvert for donating that.
