There was much discussion about what percentage or what dollar amount to put into an agreement to offer to Wesclin for their approval of our request for an extension of the Broadway TIF. Alderman Rakers does not believe the school board will accept anything less than 50% - 60% of the \$142,000.00 that they feel then need to be made whole. The mayor is reluctant to go any higher than roughly 39% of the increment that Wesclin would receive if there were no TIF. There was much more discussion on exactly what percentage to offer. Mike Conley questioned whether there was a way to determine the growth in EAV to the school based on the TIF being in place. That will be calculated. In the end it was decided to offer a rebate of 28% of the Wesclin increment. Alderman Rakers made a motion to Authorize Presentation of Intergovernmental Agreement with Wesclin School District related to Broadway TIF extension. Second Alderman Deien. Deien, yes, Mohme, no, Rakers, yes, Sampson, yes, Berry, yes, Brown, no. Motion carried.

Alderman Brown made a motion to Authorize Rental of Storage Containers for the Park from Hasshold Storage. Second Alderman Deien. All yes, motion carried.
