### **CONSENT AGENDA**

Alderman Hooker made a motion to Approve the Consent Agenda as presented. Second Alderman Deien. All yes, Bridick absent. Motion carried. The Consent Agenda included a motion to Approve Minutes of the October 27, 2025 Regular Council meeting, a motion to Approve Bills for the month of October 2025, a motion to Approve the Payrolls for the month of October 2025, and a motion to Approve the Treasurer's report for the month of September 2025.

### **UNFINISHED BUSINESS**

Alderman Deien made a motion to Approve Ordinance #1878 Jason and Kayla Athmer TIF Agreement. Second Alderman Hooker. All yes, Bridick absent. Motion carried.

### **NEW BUSINESS**

Press Coffee owner, Mike Conley has submitted a TIF application for replacement of flooring in the coffee shop. The total cost of the project is estimated at \$13,300.00 and he is requesting a 60% reimbursement based on the previous TIF agreements he has had with the city. No one had any objections. This will be on next meeting's agenda for approval.

Alderman Hooker made a motion to Approve Ordinance #1879 Amending Chapter 48 of the City of Trenton Code of Ordinances. Second Alderman Deien. All yes, Bridick absent. Motion carried. This ordinance removes the current requirement of an architect's stamp on drawing for any multi-family or commercial structure and replaces it with the ability to have an engineer

stamp drawings. If the project cost exceeds ten million dollars then both an architect and engineer must stamp the drawings. There was very much discussion about the pros and cons of who stamps drawings and at what project cost level should both be required. This ordinance does not change the process for an architectural review of any plans submitted to the city. That will always take place, no matter the cost of the project. When the discussion came to a close, the council approved the ordinance as it was written.

Alderman Hooker made a motion to Approve Ordinance #1880 Amending Chapter 38 of the Trenton Code of Ordinances by Adding Article VI Establishing Standards for the Construction of Facilities on the Rights-of-Way. Second Alderman Sims. All yes, Bridick absent. Motion carried.

Forefront Power has approached the City for a pre-annexation agreement so they can put in a solar farm within the mile and one-half radius of Trenton. This location would be at the intersection of County Line Road and Highline Road. The city is waiting on a proposal from Forefront Power.

### **CLOSED SESSION**

Alderman Rakers made a motion to enter Closed Session for 5 ILCS 120/2(c)(5) Purcahsse or Lease of Real Property. Second Alderman Deien. All yes, Bridick absent. Motion carried. The council entered closed session at 6:38 p.m.
